The table vwPRVDR contains nine (9) fields.

This table contains information about the home health agency, including contact information, and ownership type.

1. CMSCertificationNumber(CCN): Memo – The six character identification number assigned to the home health agency by CMS.
2. ProviderName: Memo – The name of the home health agency as it appears in the CMS certification system.
3. StreetAddress: Memo – The street address of the home health agency.
4. City: Memo – The city in which the home health agency is located.
5. State: Memo – The two character postal code for the state or territory in which the home health agency is located.
6. ZipCode: Memo – The five-digit ZIP code of the home health agency.
7. Telephone: Memo – The ten-digit telephone number of the home health agency.
8. OwnershipType: Memo – The general control type of the home health agency.
Categories include:
 - Voluntary Non-Profit – Religious Affiliation
 - Voluntary Non-Profit – Private

 - Proprietary
 - Government – State/County
 - Government – Combination Government and Voluntary

9. DateCertified: Date/time – The original date the home health agency was certified to participate in the Medicare program.

The table vwSRVC_PRVDR_XWLK contains four (4) fields.

This table indicates the Medicare-certified services that a home health agency provides. If an agency provides a specific service, there will be a record for that service on this table. If there is no record for a specific service, the agency does not provide that service.

1. CMSCertificationNumber(CCN): Memo – The six character identification number assigned to the home health agency by CMS.
2. ProviderName: Memo – The name of the home health agency as it appears in the CMS certification system.
3. ServiceId: Byte - The service identification number for the service provided.
4. ServiceDesc: Memo – The description of the service provided.

This table contains the patient outcome and process quality measure values for each home health agency.

1. CMSCertificationNumber(CCN): Memo – The six character identification number assigned to the home health agency by CMS.
2. ProviderName: Memo – The name of the home health agency as it appears in the CMS certification system.
3. MeasureId: Long integer(4) - The identification number of the patient outcome or process quality measure for which a value is reported.
4. MeasureDesc: Memo - The measure description for the quality measure.
5. Percentage: Memo - The home health agency's risk-adjusted percentage value for the quality measure, or, if the measure is not calculated, the reason why.

The table vwSTATE_OUTCM contains four (4) fields.

This table contains the state averages for patient outcome and process quality measures.

1. State: Memo – The two character postal code for the state or territory.
2. MeasureId: Long integer(4) - The identification number of the patient outcome or process quality measure for which a value is reported.
3. MeasureDesc: Memo - The measure description for the quality measure.
4. Percentage: Memo - The state average risk-adjusted percentage value for the quality measure.

The table vwNATIONAL_OUTCM contains four (4) fields.

This table contains the national averages for patient outcome and process quality measures.

1. Country: Memo – This field contains a constant value of “Nation”.
2. MeasureId: Long integer(4) - The identification number of the patient outcome or process quality measure for which a value is reported.
3. MeasureDesc: Memo - The measure description for the quality measure.
4. Percentage: Memo - The national average percentage value for the quality measure.

The table vwZIP_HHA_SRVCAREA contains three (3) fields.

This table lists all the ZIP codes in which each home health agency has provided services to patients.

1. CMSCertificationNumber(CCN): Memo – The six character identification number assigned to the home health agency by CMS.
2. ProviderName: Memo – The name of the home health agency as it appears in the CMS certification system.
3. ZipCode: Memo - Lists the five-digit postal ZIP code that corresponds to the area where the agency has provided services to at least one patient during the data collection period.

The table vwHHCAHPS_MSR_PRVDR_XWLK contains five (5) fields.

This table contains the patient experience of care survey measure values for each home health agency.

1. CMSCertificationNumber(CCN): Memo – The six character identification number assigned to the home health agency by CMS.
2. ProviderName: Memo – The name of the home health agency as it appears in the CMS certification system.
3. MeasureId: Long integer(4) - The identification number of the patient experience of care survey measure for which a value is reported.
4. MeasureDesc: Memo - The measure description for the patient experience of care survey measure.

5. Percentage: Memo - The home health agency's risk-adjusted percentage value for the survey measure, or, if the measure is not calculated, the text "N/A".

The table vwHHCAPHPS_NATIONAL_OUTCM contains four (4) fields.

This table contains the national averages for patient experience of care survey measures.

1. Country: Memo – This field contains a constant value of "Nation".
2. MeasureId: Long integer(4) - The identification number of the patient experience of care survey measure for which a value is reported.
3. MeasureDesc: Memo - The measure description for the survey measure.
4. Percentage: Memo - The national average percentage value for the survey measure.

The table vwHHCAPHPS_STATE_OUTCM contains four (4) fields.

This table contains the state averages for patient experience of care survey measures.

1. State: Memo – The two character postal code for the state or territory.
2. MeasureId: Long integer(4) - The identification number of the patient experience of care survey measure for which a value is reported.
3. MeasureDesc: Memo - The measure description for the patient experience of care survey quality measure.
4. Percentage: Memo - The state average percentage value for the patient experience of care survey measure.

The table vwMSR_DATE_RANGE contains two (2) fields.

This table contains the beginning and end dates of the data collection period for each measure reported on Home Health Compare.

1. Measure Name: Memo – The descriptive measure name as it appears on Home Health Compare.
2. Date Range: Memo – The months covered by the data collection period for this measure.
